VESTRY MINUTES 2020

The Parish of St James and St Brendan 55 Charlotte St., Port Colborne, Ontario

Minutes of the Annual Vestry Meeting February 14, 2021

1. Opening Prayer

The meeting was opened with prayer led by The Rev. Jody Balint.

2. Vestry Clerks

The Rev. Jody Balint appointed Pat Davis and Linda Lamarche as vestry clerks There were 33 eligible voters registered for the vestry.

3. Territorial Acknowledgement

Robynn read the Territorial Acknowledgement for the vestry.

4. Rules for the Vestry

Leslie reviewed the rules to ensure that the vestry ran smoothly and allowed for individuals to share their comments, questions or concerns. This also ensured that people on electronic devices and phone ins were included in any comments &/or discussions.

Jody then reviewed the criteria for voting privilege.

5. Approval of the Agenda

The agenda was presented with no comments.

MOTION: That the agenda be accepted as printed.

Mover: Robynn Bliss 2nd: Tim Kennedy. The Motion was carried unanimously.

6. Minutes of 2020

The minutes were presented to the vestry with no comments.

MOTION: that the minutes be accepted as printed.

Mover: Pat Davis 2nd: Lowell Bliss The motion was carried unanimously.

7. Questions Arising

There were no questions arising from the minutes of 2020.

8. Annual Reports

- a) Rector's Report
- b) Rector & People's Wardens' Reports

There was no comment on these reports.

MOTION: that the Rector and Wardens' Reports be received.

Mover: Wendy Saunders 2nd: Kate Brown. The motion was carried unanimously.

9. Ministry and Organization Reports

There was no comment on any reports in this category.

MOTION: that the reports of the other ministries and organizations be received.

Mover: Lynda Reinhart 2nd: Kathy Kairies. The motion was carried unanimously.

10. Financial Reports

Leslie reviewed the financials and reported that our situation was not as bad as we initially

expected. We received a \$10,000 loan for the Diocese and we cashed in some of our investments to cover Phase 1 of the Guild Hall roof repair. This expense was \$38,000. We have also received a few large donations that have helped our situation. During 2020 we only were able to pay \$23,500 of our \$40,000 assessment. We have not been billed for the remainder and at this point it is unclear if we will have to pay the balance. The liabilities presented at the end of the budget include items we owe and debts that we are unsure as to whether we need to repay. The Park Project has received income from federal grants. The garden project had to be modified due to covid restrictions but Sandi Marr, the coordinator provided pots of flowers or herbs to seniors in their homes to grow and care for over the summer and fall months. A second grant for seniors, also coordinated by Sandi Marr, permitted the purchase of sixteen I Pads. Sandi then started meeting with seniors who were loaned an I Pad to assist them with socializing. A Summer Jobs grant allowed us to hire a student to work in the park. Kathleen Hogan did a wonderful job caring for the park and actively spoke with passersby to share the history of the park and the work we were trying to accomplish. Definitely an asset to our endeavours. Pledges are still trickling in and there have been some donations for pavers. There have also been a few

it was explained that we cannot draw on them for purposes other than their intended use.

Mover: Norbert Gieger 2nd: Linda Lamarche. The motion was carried unanimously.

small grants. The income was \$66,851 and outflow was \$66,280. These included bank fees and bills for utilities, salaries, purchases for the park, payment on the mortgage of \$10,000 and interest on the mortgage. This interest was signed back to the church as a donation. Leslie explained the "Other" accounts. There was a question about drawing on the other accounts and

11. 2021 Proposed Budget Leslie explained that it was difficult to develop this budget because there are so many challenges and uncertainties ahead. She explained too that she used the 2020 budget numbers for the 2021 proposed budget. This budget is strictly what we need to run the church. There are no frills, and no outreach funds in this budget. The Diocese recalculated our DMM assessment to \$33,454 which is a reduction. \$15,000 from the Rectory Fund has been transferred to the operating income. By year's end a deficit of \$33,414 is projected. There is no House Tour planned but there are a few smaller fundraisers planned. It is hoped that the Lenten lunches and other meal fundraisers will bring in \$5000. As it is unclear if we have to repay the Diocesan loan, we must include it in the proposed budget as if we do have to repay it. Jody commented that this a no frills budget and that there is lots she would like to do but at present can't because of the Covid restrictions. Leslie ended her presentation by saying that we cannot keep having deficit budgets if we wish to remain a viable presence.

MOTION: that the proposed budget be accepted as printed.

Mover: Leslie Kennedy 2nd: Pat Davis. The motion was carried unanimously.

12. Parish Council 2021 Jody asked those present if there were any nominations from the floor. There was one name raised but they had left the meeting so it could not be confirmed if they wished to let their name stand so Jody ruled that the name would not go forward. There were no other comments.

Motion: that nominations for the proposed slate of members for parish Council be closed.

Mover: John Hogan 2nd: Leslie Kennedy.

The Motion was passed unanimously. Jody then acclaimed the parish Council.

13. Diocesan Licensing Agreements

Jody presented a summary of the motion. There was brief discussion about the fact that Canon Law gives the decision making authority for the parish to the Corporation and what was the purpose of the motion. Jody suggested that the Diocese just wanted it made clear to everyone that the corporation is the legal authority in the parish. It was suggested that this could have been handled in a manner differently from a motion. Agreement followed.

MOTION: that the parishioners understand that the Corporation is the parish's decision making body for licensing agreements.

Mover: John Hogan 2^{nd} : Kathy Kairies. The motion was carried with a 95% majority.

14. Single Use Plastics Jody reminded everyone that this was a motion that was approved by vestry last year. The motion this year is a reminder of our commitment to continue to move forward with the reduction/elimination of single use plastics.

MOTION: that we continue with our commitment to eliminate single use plastics by 2022.

Mover: Kate Brown 2nd: Lowell Bliss. This motion was carried unanimously.

15. Adjournment

Motion: that the vestry meeting be adjourned.

Mover: Tim Kennedy 2nd: Wendy Saunders. The motion was carried unanimously.

16. Commissioning of the new Parish Council

Jody asked everyone to stay connected for the commissioning of the new parish council. She stated that while she recognized that St J&B did this at the first Sunday service following vestry, since we were still in lockdown and probably not going to be able to have in-person services anytime soon, she wished to do it before we left the meeting.

17. Appreciation: Jody expressed her appreciation for the work Wendy has done and that her leadership will be missed. She also thanked the Parochial Committee for their work and for being responsible for her being accepted into the St J&B family. Lowell thanked the volunteers in the parish.

18. Closing Prayer

Jody closed the meeting with prayer.

RECTOR'S REPORT

My Dear Friends in Christ.

First, let me say thank you to everyone for your continued support, devotion, and love for this parish. We have survived another year of the Pandemic, which is a great accomplishment. I would also

like to say thank you to everyone who submitted a report and submitted it on time. Presently, it is 6:30 am on the 8^{th,} and I am still struggling to write my report. Sermon writing would seem to be easier. My report is supposed to reflect the past year, it is supposed to be uplifting, enlightening and bring focus to the year ahead. Let's see I how I do.

When I look back on 2021, I will admit there is some sadness for I realize that our building was physically closed for over 7 ½ months. Yet even though our building was closed that did not stop us from doing the Lord's work. We were still able to celebrate the Lord, share in God's grace and love.

Here are just a few of the amazing ministries that happened throughout the year.

- We had a wedding this past Summer
- We had a baptism in the fall.
- ❖ We were still able to do our Sunday Service both online and in-person.
- We celebrated Peace Pole Service, Taize Service and the Thursday Healing Service
- We also introduced a new Praise and Worship Service

As a parish community you are resilient. You have the ability to withstand adversity, to bounce back and grow despite the curve ball of not having a rector for two years and then having to deal with the ups and downs of the pandemic. I know that most of us were hoping that 2021 would have been the end of the Covid Pandemic. Unfortunately, the world has not been able to shake this crazy illness but that is okay because we are resilient, and this year is going to be better, and we are going to be stronger. This year we are going to grow, and we are going to live and to quote a dear friend, "if we do not live, we will die" and none of us wish to die, at least not yet. So, how do we live, how do we grow and become more vibrant? We plan, we focus, we listen, we support and we love.

Last year we started to work on our Parish Mission Action Plan. The hope was to be able to present it to you at Vestry, unfortunately between Covid and closures, a monkey wrench was thrown into the plan.

The purpose of a Parish Mission Action Plan allows a parish to be intentional in how it wishes to service the Lord. Intentional in the work that it wants to do and can actually do. It will allow us to have a "Fullness of Life in Your Neighbourhood and be reflective of God's unique call to mission in the Parish of St. James and St. Brendan."

I would like us to still work on this throughout this year and hopefully be able to present it to everyone at Vestry for approval next year.

Another thing we must do if we wish to flourish is understand our finances. When you look at the proposed budget, you will see that it is a pretty bare bones budget. Only \$24 802 at this time, is allotted to outreach. The remaining \$304 732 is to pay bills. It cost us \$304 732 to run and operate this parish. I need you to be aware of that. \$304 732 to just to run the parish.

I would love for outreach line in our budget to be \$100 000's; however, if we can not support ourselves then how can we support others. You might have heard me speak of Stewardship before and this is what stewardship is all about; it is about taking care of ourselves and those around us. Sometime, when people hear the word stewardship, they assume it is about fundraising. It is not. As I said it is about how we take care of ourselves and others. By being able to take care of ourselves we are able to provide resources, outreach, and programs to those in the parish and within the community.

Being able to take care of ourselves, also means we have to remember our buildings are old. Things are starting to need repair. Last year half of the roof on the Guild Hall needed to be done, this year we have to replace the air conditioning in it. Thus far, we have used some of our savings, but we do not wish to use it all. Therefore, to help with some of these costs we do look for grants to help us out, but money is tight. At last parish council meeting we briefly spoke about how if we are to move forward, we need to come up with sources of sustainable income. In other words, instead of having the guild hall filled with one-time renters and party goers, it needs to become a permanent home to a few organizations to help generate regular and consistent income. Please note, I am not saying we won't rent to parties, celebrations, and Christmas Bazaars in the hall, of course we will. However, the hope and the goal is that the income from those events would be surplus money for such things as outreach and programs, not necessarily to pay bills.

I would be remiss if I did not acknowledge our debt. Yes, we still have the mortgage on the park, and we do owe money to the Diocese. Corporation and I, in discussion with Parish Council have come up with a plan to start paying down our debt. Slowly but surely, we will get rid of it all.

Another thing I wish you to be aware of is how I have been using The Rector's Discretionary Fund. Every priest is allowed to have discretionary fund to use as they see fit. In our budget I have been alotted \$500 a year. Last year, thanks to the Rector's BBQ and money I was given for funerals and weddings, I raised over \$2000 for a total of \$2500 in my Rector's fund. The money from the discretionary fund has gone to the sound system project, the Blessing Box, supplies for the church, financial support to a couple families within the parish and a few people living on the street in Port Colborne. I will always use my discretionary fund to either help people of the parish personally, people within the community or the church itself.

Moving forward into 2022.

The hope is that our building will be open by March for us to worship together as a familiy. However, whether we are open or not I know that we will still be able to celebrate the Lord in a mulitude of ways. Here are a few events I would encourage you to come to and pariticipate in and mark on your calendar,

- Mariner's Service TBA
- Pancake Dinner March 1st,
- Lenten Lunches every Wednesday during Lent,
- Holy Week Days of Prayer. Held in the Hall starting the afternoon of Palm Sunday and all day of the Monday of Holy week.

- ❖ Garden House Tour with a Strawberry and Champagne Social June 25th
- Prayer Tent will be every Friday June from 8am to 12 noon. On these Friday mornings I invite you to come say hi, come meet the community or come and pray with me.
- ❖ God willing July 18th to 22nd we will be having a Vacation Bible Camp,
- Rector's BBQ Sunday, September 4th
- Harvest Festival
- Christmas in the Park TBA
- Concert on Sunday, December 4th with Father Mark Curtis.

This list is just a few of the things that are tentatively planned. Knowing a few of the people on our unofficial-official Social committee I am sure there will be a few more events to come.

Last year I asked the question Why do we do what we do? Is it just because we are expected to? As I said, last year, I would like to believe that we do what we do because we are all disciples of Christ, and we are stewards of the world. I pray that every action, every conversation, every phone call and every email between each of us, is done out of one's deep love and gratitude for Christ. Nothing is done out of obligation but out of the sheer joy of having a relationship with Christ and being a member of this community.

Again, I thank you for everything that each and every one of you have contributed to St. James and St. Brendan throughout this year. I thank you for your time, your talents, and your treasure. I thank you for your prayers and your love of Christ and the sharing of His Gospel.

We are a great parish, and I am looking forward to journeying with you, evangelizing with you and sharing the Word of Christ with you throughout 2022.

To them we say you are the best and we are blessed for your contributions.

We invited churches to decorate a tree but none took us up on the offer so we each chose a tree and a theme for our tree. A group of women gathered to roll out and bake over 400 Christmas cookies. Others decorated and bagged the cookies. On Friday, November 26th we had a fire pit and we served hot chocolate and cookies and popcorn. It was a very cold night but those who braved the elements were warmed in body and spirit! Members of the choir and congregation sang Christmas carols. It was a memorable evening. On Saturday, November 27th we were very grateful to have slightly warmer weather and even a little bit of sunshine! Mark Wakefield entertained us with holiday favourites for the entire morning! In the afternoon we were treated to a mini concert from the Niagara Women's Chorus -including an appearance from the Town Crier who came to announce them. Leslie and Kate had prepared crafts for kids (and several adults!) to do. Bronwynn Bliss volunteered to make balloon animals. Rev Jody kept the popcorn popping. We handed out more cookies as well. Lemayzzz Meats set up their barbeque on the very edge of the property and served up sausages and hotdogs. (They surprised us by generously donating the meat and the profits from their sales!) Santa and Mrs Claus also popped by to say hello!

Everyone who came seemed to enjoy themselves! Our intention is that Christmas in the Park be an annual event that members of the community will come to look forward to with much excitement.

SENIORS WITH CONNECTIONS

"Seniors with Connections" is a federally government funded program to improve the quality of life for seniors during Covid. The goal of "Seniors with Connections" is to provide seniors with iPads on a loan basis as well as iPad support to help seniors feel more connected to the outside world.

As with the summer gardening grant program of 2020, this 2021 iPad program has been very well received. Over 40 people have participated in this program since its beginning. This government grant allowed us to purchase 16 iPads. These iPads are shared amongst participants.

I've been extremely pleased to see how user friendly iPads are especially for seniors with limited or no previous technological experience. Some of our participants are from St. James and St. Brendan Church while others are from the broader community. We have tried to share the good news about this program and welcome newcomers into our group.

There are many positives from this initiative. For me personally, the highlight of the past year has been meeting with individuals and building relationships. This seems especially important when so many activities have been put on hold during Covid. We miss seeing the people we normally see because of restrictions. The gift of friendship is even more important during Covid times.

Each week I meet with seniors in small groups or one-on-one for iPad training and support. Seniors find their iPads help them "pass time" more quickly. They are able to see their friends and family on facetime. While unable to attend church in person, church services are available online. Social services are also accessed on line. There are many games such as Crossword puzzles, Word games and Card games available on the iPad. All of these activities keep our minds alert, active and engaged. Some seniors enjoy searching information such as new recipes or skills like knitting. Others enjoy listening to music, podcasts and news. Others use their iPad to take photos to share in emails with others. Facebook is also a helpful way for seniors to follow the daily life of their friends and family.

These are just a few of the ways seniors are utilizing their iPads to increase their social connection at a time of social isolation.

In closing, thank you for the opportunity to give leadership to this beneficial program. I'm grateful for each person in "Seniors with Connections" and for our learning journey together. We are teachers and learners together. We are never too young or old to learn something new. Bright blessings for the road ahead!

GRANTS REPORT

2021 was one of those roller coaster years. Early in the year we responded to the call for proposals for the Ontario Summer Jobs funding. We applied and were approved to hire for two positions, one for the upkeep of Mariners Park and the second for an Assistant Archivist.

In March we completed a project under New Horizons for Seniors Project funded by the Federal Government for \$22,994. It had been a successful project with lots of positive feedback from seniors so that same month we submitted another grant for \$18,491. from the same funder to continue the program to purchase additional iPads and continue to offer the program to more seniors. We were funded once again.

We investigated submitting a grant to the Ontario Trillium Foundation to do needed renovations at the Guild Hall. We spent many weeks securing quotes for what was needed and consulting with the funder. Ultimately, we were advised that our project did not fit their criteria and we were advised to wait until another call for proposals that would be a better match.

The final submission of the year was a request for \$25,000 for a Walking on Water grant. The grant was submitted a few days before Christmas, with a final presentation and decision to come in early 2022. Lynda Reinhart.

MARINERS PARK

While the pandemic for another year again dampened activities, work continued this year maintaining and enhancing the park which is being used increasingly as a venue for parish and community worship and events.

The sustained financial support of the parish and wider community is encouraging. General and memorial donations together with premises rentals have funded the operating expenses including taxes and mortgage costs. Federal funding supported the employment of a summer student to look after the grounds and again grow food for outreach.

Regular mortgage payments are being made with the mortgage outstanding now slightly in excess of half of the original amount. When you consider that and the physical improvements to the space and buildings, it is a testament to the commitment of the parish to revitalizing this once derelict run-down area and sharing this with our neighbours. Our efforts have been noticed and are reflected in the community support we have received and hopefully will continue to receive.

The use of the park itself for ministry and parish events while still limited due to the pandemic is an important step in realizing the potential of this space and we look to increased usage in the year ahead not just for parish events but also to host activities for the wider community.

Plans for 2022 include the installation of permanent signage which would clearly identify the park as an extension of St. James and St. Brendan Anglican Parish. Once this work is completed, we will be able to hold a parish and community gathering to acknowledge the many generous contributions made to date and invite the public's support as we move forward.

FOOD WITH FRIENDS (OUT OF THE COLD)

It takes a village to meet the needs of our community. Our former leader, Linda Lamarche, had one last wish for this ministry before she passed and we granted her that wish. Since the fall of 2021, we have changed the name of Out of The Cold to Food with Friends.

Our ministry involves 5 churches: Central United Church, Port Colborne Brethren in Christ, Forks Rd. East United Church, St. James ad St. Brendan, The Gathering Place, and one local business DeLuca Foods. All of the church volunteers have been incredibly faithful in continuing to serve hot take-out meals every Tuesday all year long since March 2020.

We continue to follow the restrictions due to the pandemic. Safe distancing policies and wearing of masks were put into place to ensure the safety of our guests and volunteers. We were served between 40-50 hot meals every Tuesday in the past. Since November 2021 we are now serving 80-90 meals each week.

We are thankful for church donations, personal monetary gifts, donations of foods from individuals and the generosity of reduced prices from 2 of our local grocery stores, Food Basics and No Frills. We are now in the process of applying for a grant through United Way. At this time, I would like to thank all the support of our St. James and St. Brendan family and our team of volunteers.

As well we are extremely blessed with the continuing support of volunteers from other churches and a catering business that meet the needs of our community. I give thanks to each and everyone for their faithfulness and their love for others.

MOTION 9: DON LICENSE AGREEMENTS

The licensing template is intended to clarify regular or frequent use of church buildings or spaces – and especially long-term arrangements with day care centres and schools. It not intended for use with groups that will be using the church on a one-time basis.

The policy of the diocese is still that even one-time users of church premises must provide evidence of liability insurance or obtain user group insurance through the diocese, and sign off on a commitment to abide by the Diocese of Niagara's Sexual Abuse and Sexual Harassment policy.

Canon 4.7 (23) allows parishes to enter into agreements for the use of parish space for periods of up to three years (inclusive of all renewals). For agreements of more than three years, Canon 4.7 (22) requires the approval of the Vestry, Synod, and Bishop. The requirement for approval by all three parties arises from a statute of the Province of Ontario (Anglican Church of Canada Act, 1979).

ENABLING MOTIONS FOR VESTRY APPROVAL

Short term agreements:

A Motion to Empower Corporations to Enter Into Site Use Agreements Of Less than Three Years

BE IT RESOLVED THAT this vestry authorizes the Incumbent and Churchwardens to consider and, if they deem it advisable, to approve leases, licenses, or space agreements of less than three years inclusive of all renewals

AND THAT this authorization shall extend only to agreements that include the following provisions:

• That the agreement may be terminated by *St James & St Brendan's Anglican* upon sixty days' notice

- The lessee or licensee shall provide proof of liability insurance
- The lessee or licensee agrees to abide by the Sexual Abuse and Sexual Harassment policy of the Synod of Niagara;

AND THAT if there is any conflict between this resolution and any authorization or approval resulting from it, the Canons of the Diocese of Niagara, it is understood that the Canons shall prevail.

Long term agreements or renewals in their fourth year:

A Motion to Empower Corporations to Enter into Site Use Agreements of more than Three Years

e.g. "to meet weekly in the parish hall" or "to operate a music school in the church basement") subject to the following terms and conditions: (outline the terms of the lease, license, or space agreement OR summarize by referring to the lease, license, or space agreement presented to the Vestry) The approval of the Bishop and Synod of The Diocese of Niagara
